# Issues Impacting Childcare

**New London County** 

There are 84 Family Childcare and 108 Center-based licensed programs in NL County to total capacity of 4,571 seats.

### Impact on Our Community

- Parents opt out of the workforce, **impacting local businesses**.
- Businesses have difficulty hiring new employees, impacting local economy.
- Young children miss out on an early learning environment preparing them for success in school, **affecting the future workforce**.



# Framework

**Vision**: Every family has access to affordable, high-quality childcare.

**Outcome**: Increase the number of childcare slots by 500 to help reduce the 41% gap between childcare demand and availability by 2030.

#### Workforce

Increase the childcare educator workforce by 50 educators by 2030.

#### **Innovation**

Pilot new innovations that increase childcare capacity by 2030.

### **Accessibility**

Quality childcare is available and affordable for all.

#### **Data**

Collect regional data that informs decision making.



### Innovation

- New CT legislation allowing up to 20 family childcare incubator sites across the state.
- Maine Health's repurposing unused facility space for new childcare center business development. Portion of seats reserved for Maine Health employees.
- Missoula, Montana's shared services and childcare microsites with employer engagement.





### Workforce

- CDA Childcare Pathway Pilot through Norwich Free Academy.
- One-Stop Career Fairs in Southern ME.
- UW Coastal & Western CT Business Support Model.
- Registered Apprenticeships with CT-OEC





# Accessibility

Address childcare deserts by increasing the number of home-based **family childcare providers.** 

These family childcare homes are often more accessible and affordable than center-based childcare...
